This pathfinder introduces the exporter to the key sources of information about the Government of New Zealand and its legal system. It also includes sources which provide access to case law.



Parliament of New Zealand | Pāremata Aotearoa

A very comprehensive site covering a wide range of topics relating to the New Zealand Parliament. It includes access to MPs and their electorate profiles. The search facility enables exporters to search for references to industries, products or markets. The Select Committee for Foreign Affairs, Defence and Trade is easily accessed through this site.



Online Coverage of Parliament

This website provides searchable online coverage of Parliament using YouTube clips or posts. The posts/clips may be delivered in answer to keyword searches, or having clicked on 'Latest Topics' and 'Latest Bills & Questions'. By clicking on the name of a Member of Parliament you are able to see all the video posts that are available relating to that Member. The site was built for the Clerk of the House to make Parliament more accessible. It also links to social networking tools such as Facebook.



New Zealand Government

This is the official website of the New Zealand Government. It gives quick access to Portfolios such as Trade and Trade Negotiations with Press releases, speeches and newsletters.



New Zealand Legislation

Legislation is a generic word which covers all 'pieces' of New Zealand law. The laws themselves may be called Acts or Statutes, and as well there are Regulations or Statutory Regulations. This website provides free public access to New Zealand Acts (Public, Local, and Private) - these are laws made by Parliament and are sometimes called the New Zealand Statutes. Bills, which are proposed Acts, and Statutory Regulations are also available on this website.

This site focuses on the services that both local and central government can offer. It also contains contact details for public organisations and local councils under an A-Z listing. Use the search facility to search for trade and export.

Based on TheyWorkForYou.com a similar site in the United Kingdom, this site aims to make it easier for people to access the operations of the New Zealand Parliament. It creates links between the debates of the House of Representatives and Bills, Ministerial Portfolios, Committees, and MPs.

About Courts provides information about the role, history and structure of the courts. Court Business includes court sitting calendars and case summaries, and assists media and lawyers in using this information. From the Courts provides news from the Higher Courts, including decisions of public interest.

There is a search facility and exporters can search on 'business' or 'companies' to bring up cases including New Zealand firms.

Law Commission | Te Aka Matua o Te Ture

The Law Commission is an independent crown entity. It is a central advisory body established to undertake the systematic review, reform and development of the law of New Zealand. From time to time the Law Commission publishes study papers on issues for discussion. For example a search on 'trade' retrieves a number of papers relevant to the exporter.

The Commission's website includes a link to Talklaw. TalkLaw is the New Zealand Law Commission's online consultation site. It gives you the opportunity to have your say on law reform projects. Input from the public is important and will influence recommendations for changes to the law.

This website provides free access to legal information in New Zealand with case law, legislation and treaties. The case law held on this database is very recent so cases of significance may not be available through this service. However it does include decisions of the Customs Appeal Authority of New Zealand and New Zealand Commerce Commission Decisions. The latter may give you information about ownership of companies, and mergers and acquisitions.

The Commerce Commission enforces legislation that promotes competition in New Zealand markets and prohibits misleading and deceptive conduct by traders. The Commission also enforces a number of pieces of legislation specific to the telecommunications, dairy and electricity industries.

The Companies Office is the government agency responsible for the administration of corporate body registers, including the Companies Register. Its online services include forming a company, obtaining a company tax number, maintaining company details and managing receiverships, liquidations and voluntary administrations.
